### Did You Know?

**Tidbits to ponder courtesy of Territorial Governor Ranger Six**

SDQ (Stage Disqualification) and DNF (Did Not Finish) stages are scored the same. That score is the maximum allowed time for that stage, which is the round count times 5 plus a 30 second penalty. A typical stage round count is 24 x 5 seconds + 30 seconds for a stage score of 150 seconds. Two SDQ's, two DNF's, or one of each, results in a MDQ.

The NEW Regulators will post the results of a match with no time score for a MDQ.

The 2022 End of Trail (CAS World Championship) will take place in Phoenix, Arizona, and the 2022 CAS National Championship (the name Winter Range will have been retired) will be hosted in Oklahoma City, Oklahoma.
