NRA Marksmanship Qualification Program (MQP)

The NRA Marksmanship Program is a self-paced skill development program open to the public. Qualifications offered: Pistol, Defensive Pistol I, Defensive Pistol II and Rimfire Rifle. Other Qualifications may be available if interest warrants.

Program fees per session: Club Members = \$10.00, Non-Members = \$15.00, 17 years & under = \$5.00.

Participants are required to provide a safe firearm along with ammunition and demonstrate the ability to safely handle and use it. Eye & Ear protection is mandatory. Program sessions are conducted monthly on the 3rd Saturday. Start Time: 9:00 A.M.

The next scheduled session is Saturday, August 15, 2026.
